



Online Chinese Law Programs

Law Courses

The law courses are provided on an online platform through online video, slideshows and assignments that allow flexible learning from anywhere in the world.

These courses run for a period of 1 year, and two semesters and the available courses are listed below:

Certificate

Summary

The certificate allows full access to these courses and access to the online learning platform. The homework and dissertation are not required in order to be given the certificate. Students are awarded a certificate for enrolling on the course.

Diploma

Summary

Homework and the dissertation is required and necessary. At the end of the course students will receive a diploma in Chinese law.

Students are eligible to start the certificate at any time of the year.

LLM (Masters of Law)

Summary

The online LLM is the official online LLM awarded by Beijing Foreign Studies University, the Ministry of Education and the Ministry of Justice of the People's Republic of China. Students are required to complete all the required work and complete an online defense of their dissertation in order to be awarded the LLM.

Fee

\$20,000 USD

Start date:

The start date is September each year.

The application deadline is June 10th, but students may be able to be admitted after this deadline.

Introductory Week

Students are required to visit Beijing in September at the start of the year to officially enroll at the University. Students will meet fellow students, the teaching faculty, and participate in information sessions about the program. Students will also have the opportunity to partake in a variety of trips in Beijing as paid for by the school.
